House of Freedom Church is committed to providing a safe, caring, and fun environment for all children. In consideration for my child's participation in Freedom Kids, I hereby, for myself, my heirs, executors, administrators, assigns, or personal representatives, knowingly and voluntarily enter into this waiver and release of liability and acknowledge and agree as follows:

Assumption of Risk

I understand that my child will be participating in age-appropriate activities, which may include but are not limited to playtime, crafts, Bible lessons, music, snacks, and supervised games. I acknowledge that participation may involve risks of physical or psychological injury, illness, property damage, or other unforeseen incidents, which may result from my child's own actions or the actions, negligence, or conduct of others, or the condition of the facilities or equipment.

I voluntarily assume all risks, known or unknown, associated with my child's participation in Freedom Kids.

Release of Liability

By acknowledging this waiver, I release and forever discharge House of Freedom Church, its affiliates, pastors, staff, volunteers, agents, representatives, heirs, successors, and assigns from any and all liability, claims, demands, or causes of action whatsoever arising out of or related to any loss, damage, injury, illness (including communicable diseases), or death that may be sustained by my child, whether caused by negligence or otherwise, while participating in Freedom Kids or traveling to or from any related activity.

Indemnification

I agree to indemnify and hold harmless House of Freedom Church, its affiliates, staff, and volunteers against any and all claims, suits, or actions of any kind brought by me or anyone on my behalf arising out of my child's participation in Freedom Kids, including attorney's fees and related costs.

Medical Authorization

In the event of an emergency, I authorize House of Freedom Church staff and volunteers to obtain necessary medical treatment for my child until I can be reached. I agree to be financially responsible for any medical care or treatment provided. I understand it is my responsibility to carry adequate health insurance for my child.

Snacks and Allergies

I acknowledge that simple pre-packaged snacks (such as Goldfish) may be served during Freedom Kids, unless I have specified otherwise on my child's registration form. I understand that I am responsible for notifying House of Freedom Church in writing of any food allergies or restrictions for my child.

Policies and Responsibilities

I understand and agree to the following:

- Parents/guardians must promptly return if contacted for diaper changes, restroom assistance, or other needs.
- Families are encouraged to arrive early to check-in.
- Participation in Freedom Kids is subject to the Freedom Kids Ministry Participation Policies and Release of Liability, which I acknowledge and accept.
